**The Springfield Township Board of Trustees held a special meeting Monday, May 22, 2017 at 5:30 p.m. at the Springfield Township Town Hall, 2459 Canfield Road, Akron, Ohio. The purpose of the meeting: Seeking public comment on a proposal to consider levying a \$5.00 supplemental vehicle license tax for the purpose of maintenance of township roads.**

**The meeting was called to order by Dean Young at 5:30 p.m. Patty Price, Secretary, called the roll. Roll Call: Mrs. Davis (absent); Mr. Young (here); Mr. DiLauro (here).**

**Garry Miller, 2336 Mallard and David Griffin, 457 Ewart were present at the meeting.**

**Issues discussed were:**

- **The Township could have been doing this since 1987.**
- **Once the levy is passed, it will be only \$5.00 every year. It cannot increase, stays the same every year.**
- **Questioned whether it should be put on the ballot and voted on.**
- **Out of 31 entities, 17 are currently collecting in Summit County.**
- **Will increase revenue for the road department \$71,000 and will be collected in 2018.**
- **If you buy your license and do not tell them your are from Springfield Township, the money may go to Akron.**
- **When the State cuts the budgets to the Twnship, how do they expect Townships to fund anything.**
- **Residents need to be made aware of all the facts.**
